For the present clause 4.2, the following clause will be
substituted and read as follows:

4.2. FUNDS:

The treasurer shall have charge of all funds belonging
to the Trust and his receipt, jointly signed by the
President, shall be a discharge for all funds payable
to the Trust. The treasurer shall make all disbursement
authorised by the trustees or committee and cause true
accounts to be kept of sums of money received and
expended on behalf of the Trust. Moreover the funds of
the Trust will be kept invested or deposited strictly
in the manner laid down by section 11(5) of the Income-tax
Act, 1961. Bank accounts shall be opened with any
nationalised banks. Secretary, in his absence, any one
of the Joint Secretaries, and the treasurer shall be
jointly authorised to operate on the bank accounts of
the Trust and they are authorised jointly to draw, accept,
endorse and negotiate all cheques, drafts, and negotiable
and transferable instruments.

The following clauses shall be incorporated in the Trust Deed
in addition to the present clauses and read as follows:

Clause 4.6. The accounts of the Trust shall be closed every
year ending 31st March.

Clause 4.7. If the Trust is dissolved by the act of Providence
or otherwise, the net properties of the Trust
shall pass on to any trust having similar objects
or carrying on similar activities as may be
decided by the Trustees.
